Please note, the market is weather-dependent. We will inform stallholders at least 24 hours in advance if the forecast suggests unsuitable conditions for an outdoor market.

Market hours are from 10am to 3pm. Stallholders can access the site from 9am. If you need to bump in the day before, please inform Sir George Management, and we will try to accommodate your request. The market wraps up at 3pm, but our kitchen reopens at 5.30pm, and you're welcome to continue trading until 8pm.

As this is an outdoor event, stallholders are responsible for providing their own tables, shade, seating, and display equipment.

The fee for a 3 x 3m space is \$50. If you need electricity, there's an additional charge of \$20.

Payment of stallholder fees is due 7 days before the market. An invoice with payment details will be sent once your application is approved. Please include a screenshot or copy of your stallholder insurance with your payment. ## TERMS & CONDITIONS

Terms and Conditions Stallholder Application Operation of Stalls

-1- Sir George Hotel grants to the Stallholder a license to operate the Stallholder's allocated Stall at the Sir George Hotel on the Saturday or Sunday agreed.

1.1 Subject to this agreement, the Stallholder may operate its Stall only between the hours of 9:30am and 3pm on the agreed day.

1.2 All Stallholders must set up their Stalls by 9:30am and remain set up until 3pm. Early packing up is not permitted without the permission of the Sir George Hotel

1.3 The Stallholder's right to operate a Stall at the Market is at the discretion of Sir George Management. Sir George Management may terminate a Stallholder's right to operate its Stall at any time and for any reason, including where: a) A Stallholder sells goods or products that have not been approved by Sir Goerge Management; b) A Stallholder's conduct is unacceptable, as determined by Sir George Management; or c) A Stallholder does not pay the required Stall Fee on time or at all (see section 7). Sale of approved goods/products

Stallholders may only sell goods or products that have been approved by Sir George Management.

Sir George Management reserves the right to change the floor plan of the Market, and to determine the location of individual stalls in the Market each week. Stallholders may not object, and have no claim against Sir George Management, if they are required to change the location of their Stall within the Market.

Sir George Management reserves the right to move the location of the Market or to close the Market.

Payment

Each Stallholder is required to pay Sir George Management \$50 fee.. If power is required, this is an additional \$20. Sir George will supply a power lead but not power boards.

Participation as a stallholder in the Market is by invitation only. Stallholders are invited to participate in the Market based on the goods they submit for the approval of the Sir George Management.

Persons or entities who Sir George Management approves to be stallholders at the Market (Stallholders) agree to comply with the following terms and conditions in relation to their operation of stalls at the Market.

It is a requirement of participation in the Market that Stallholders have carefully read and familiarised themselves with the information contained in the Stallholder Information Guide, and all Market policies and procedures, and that they comply with all Market policies and procedures when operating their Stalls.

Sir George Hotel is a non-smoking environment and Stallholders must not smoke or permit smoking at their Stalls.

## TERMS & CONDITIONS Continued...

### Insurance

While the management carries insurance to cover public risk, stallholders are required to take out a similar insurance cover in case stallholders are found personally liable for any damage caused to members of the public or to the property of members of the public. If an incident occurs within a stallholder's space which involves the stallholder, it is essential the stallholder notifies Sir George Management as soon as possible, click on the link provided if you need assistance with this.

### Liability and Indemnity

Sir George Management takes no responsibility for, and will not be liable for, any damage to, or loss of, property of any Stallholder at any time in the Market except where such damage or loss is solely caused by the negligence of Sir George Management.

The Stallholder occupies the area in which the Stall is located at his or her own risk entirely. Each Stallholder releases and holds harmless Sir George Management from all and any claims made against Sir George Management arising out of the Stallholder's use and occupation of the area in which the Stall is situated.

The Stallholder has no claim against Sir George Management for any loss or damage to a Stallholder arising directly or indirectly from: a) any decision by Sir George Management to terminate the Stallholder's right to operate a Stall under section 1.4; b) any circumstance where Sir George Management is required to, or determines to, close the Market; c) any circumstance where Sir George Management is required to, or determines to, move the location of the Market; or d) any order made by any government, semi-governmental, local or statutory authority restricting the Stallholder's occupation of the marketplace.

The Stallholder agrees to indemnify and keep indemnified Sir George Management against all actions, claims, suits, and demands brought, maintained or made against Sir George Management by any person arising out of the Stallholder's, and its employees and agents', occupation or operation of the Stall.

The Stallholder acknowledges that these Terms and Conditions apply not only to the Stallholder but also to anyone who works on the Stallholder's behalf.

### No inducement

The Stallholder acknowledges that he/she has not been induced to enter into this agreement by any statement or representation made or given by or on behalf of Sir George Management
